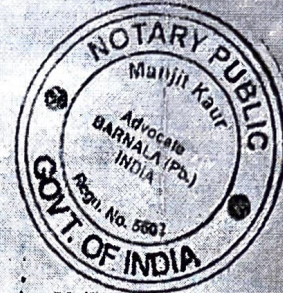

Sir,

With reference to the above subject :

2. After going through the documents alongwith affidavit produced by the Management of your School, the recommendations of the District Education Officer (Sec. Edu.), Barnala and the Director Education Department (Sec. Edu.), Punjab, Chandigarh, requisite No Objection Certificate is issued on the following terms :

1. In future if this fact comes to light on any application/inspection that at the time of getting the No Objection Certificate the application has been given on wrong information and/or the instructions issued by the Punjab Govt. from time to time are not complied with and similarly the conditions mentioned in the affidavit are not being complied with, then in such circumstances this No Objection Certificate can be withdrawn at any time.
2. Teaching Punjabi upto Tenth Class in your School will be compulsory and C.B.S.E., New Delhi would definitely make arrangement to take examination of Punjabi in such schools and it is stated that in case of failure the No Objection Certificate would be withdrawn immediately.
3. After getting the affiliation with C.B.S.E. New Delhi the Management of the School will be liable to pay the salary and other allowances etc. to the teaching and non-teaching staff of the School like Govt. employees. In case of not doing so the No Objection Certificate would be withdrawn.
4. You yourself and your Management would make sure that whenever any kind of information is called for the District Education Officer of any Senior Authority of the Education Department then the requisite information would be made available to him and requisite held would be extended.

This Sanction is issued as per the order of the Hon'ble Education Minister dated 13-10-2008.

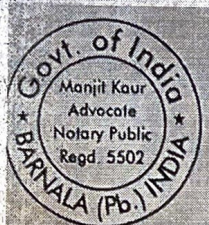
